

Recognize market-relevant developments early

A colour code system identifies the phases in the lifecycle of standards and shows you which updates are being planned. Thus, you can adjust your products or services to changed market conditions in good time.



Finding instead of searching

Search by title or document number or in the full text in a targeted way. Further refine the search results by means of filters (e.g. status changes, document type, subject field, type of legal reference, etc.).

All ÖNORM and ISO standards included in the portfolio of your standards management solution effects 2.0 and the favourite folders in effects 2.0 are synchronized automatically and are available as bookmarks in meinNormenRadar.



Find out which legislation refers to your standards

Standards referred to in legislation are specifically flagged and can be quickly found by means of filters. The related legal acts are described by their number, title, scope and date of publication and are provided with a link to the full text in the legal information system RIS of the Austrian Federal Chancellery or in the EUR-Lex system of the European Union.



Recognize opportunities for shaping standards in time

As projects proposed are also identified by a separate status, you can see, monitor and influence the development of new topics earlier. When proposed projects or drafts are open for public consultation, you can directly submit your comments. The deadline is clearly shown.



Get information on changes by e-mail

Austrian Standards regularly checks your bookmarks for status changes. When you "subscribe to Info Mail", you are informed of standards with status changes by e-mail at the interval specified (daily, weekly, monthly or quarterly).





Save your regular search queries

You can bookmark frequently used standards and entire hit lists for future queries and organize the bookmarks in folders.
